Closing keynote Secured --- Andy Stumpf

TACC has secured **Andy Stumpf**, as the closing keynote at the **2020 TACC Annual Meeting**, **March 15-17 at the Woodlands Resort in The Woodlands**, **TX**. In 2015, Andy broke the world record for absolute distance traveled in a wingsuit (*also called a "squirrel suit" because when worn, the jumper resembles a flying squirrel*) to raise one million dollars for the Navy SEAL Foundation. Andy is an expert (*both in practice as a SEAL and a businessman*) in leadership, adapting to change, communication skills, teamwork, handling stressful situations, decision making, and peak performance. He has been featured on many top television programs, publications, blogs and podcasts and hosts his own podcast, Cleared Hot. You may have seen him on CBS' TV Reality Show "Hunted" as a hunter for fugitives. You won't want to miss Andy's take on leadership in high risk, high consequence environments!

TACCs **Tommy Engelke** says, "What makes this year's meeting special is that it's located on the northwest edge of Houston and not in Houston so traffic is not a problem, however if you want to take in the Houston Livestock Show and Rodeo (*March 3-22*) in the afternoon, it would be convenient to do so!"

Once again, South Texas Conferences exceed <u>Expectations!</u>

TACC held the South Texas trifecta events October 30-31 in Corpus Christi --- 4th Annual Co-op South Texas Board Chairmen's Conference, Shrimp Boil, and the one-day TACC South Texas Cooperative Leadership Conference. Both conferences had great attendance, despite a busy ginning season. Thank you to the 18 conference sponsors who helped make these events possible and to the nearly 80 people in attendance.

For the fourth year, the Board Chairmen's Conference was held at Gulf Compress with a loaded panel of speakers. Kicking off the conference was an engaging discussion between co-op leaders and board chairs about what general managers value most about their board president and the expectations of a co-op director. Renouned co-op attorney, **Gary McLaren**, from the McLaren Law Firm in Lubbock, discussed legal issues directly affecting co-op board chairs. **Jon Jones**, Board Chair and **Seth Stephens**, General Manager from Producers Co-op Elevator in Floydada, shared what it takes to make the co-op general manager and board president partnership work. **Dr. Mike Boland** from the Agricultural Economics Department at the University of Minnesota along with **Dr. John Park**, Roy B. Davis Professor of Agricultural Cooperation at Texas A&M University in College Station, closed the meeting with a powerful presentation on good and bad trends occuring in co-ops.

The TACC South Texas Leadership Conference, held at the Omni Corpus Christi Hotel, kicked-off Wednesday, October 30 with the annual Shrimp Boil cooked by a team of co-op leaders and new head chef, **Tyler Cross** of Smith Gin Co-op in Odem, and **Aaron Peña** of Valley Co-op Oil Mill in Harlingen. The conference began with **Kevin Brinkley** of Plains Cotton Cooperative Association in Lubbock discussing current and long-term marketing conditions in ag; **Greg Taylor**, CPA with D. Williams and Company CPA firm in Lubbock provided important updates to audits and tax laws; **Tony Morton**, CFO, PYCO Industries, Inc. in Lubbock gave a practical approach to analyzing financial statements; **Major Chris Nordloh**, the point-person for the Texas Department of Public Safety, answered the group's pressing questions about transporation regulations during the lunch hour.

The afternoon session began with a presentation from **Dr. Mike Boland** with the Agricultural Economics Department at the University of Minnesota along with **Dr. John Park**, Roy B. Davis Professor of Agricultural Cooperation at Texas A&M University in College Station on disruptions impacting co-op board governance. **Jarron Sharp**, General Council at the Federation of Employers and Workers of America (FEWA), from Bay City, provided an overview of securing H-2A workers as well as recent updates to the program. Wrapping up the afternoon, **Gary McLaren**, attorney at McLaren Law Firm, PLLC in Lubbock, updated the group on legal cases.
