# ACC Annual Awards presented at Joint Cooperative Meeting in San Antonio



TACC's 2020 Cooperator of the Year is **Dennis Artho** with the Hereford Grain Corporation in Hereford, Texas. This award is reserved for those that have provided exceptional service and leadership, leaving a lasting impact on their local and statewide cooperative community. Dennis began his lifelong career at Hereford Grain working under his father in 1981 before taking over as General Manager in 2001. With quiet persistence, Dennis has made big moves for the co-op including starting an extremely successful food corn division, and was instrumental in bringing an ethanol plant to Hereford, opening up yet another new market for corn & grain sorghum.

The Cooperative Ginner of the Year is **David Wyatt** of Bayside-Richardson Co-op Gin in Woodsboro, Texas for his exemplary performance in and commitment to cooperative cotton and agricultural industries --- setting the gold standard for gin management. His cotton gin career began at 19 with his first general manager position! David has been the manager at Bayside-Richardson Co-op Gin since 1991 and has made numerous improvements that have increased the co-ops performance and profitability, setting new records year after year for bales ginned.





The Distinguished Service Award is presented to an industry leader devoted heavily to our kind of work. This year, the choice was too close to call, so two awards were presented to three very deserving people! The first award this year was given to **Kyle and Dayna King** of Terry County Co-op Gin in Brownfield, Texas, where they both served 31 years. Kyle's work in cooperatives started out in the gin yard as a tike with a little red wagon, and grew into a 41-year career with Dayna always working by his side.

A past president of TACC, **Ron Harkey** of Farmers Cooperative Compress in Lubbock, Texas is this year's second award winner. He began working at the local gin in high school, and eventually joined what would become Farmers' Cooperative Compress in 1995 before becoming General Manager two years later. Under his leadership, the co-op never lost money, leaving a substantial economic impact on West Texas.



Wow, if it wasn't for the press & social media constantly telling us how bad things are, we really may have had it pretty good --- especially for our rural - oriented folks. It's the little things that matter; not the big things. Our rural folks don't know it, but they are leaving unbelievable leadership marks on an otherwise what appears to be a very disoriented society.

Can you believe an FFA kid from Flatonia, Texas had the gall to get a legislator to carry a bill that is moving rapidly through the legislative process in Austin to bring an ag study program down into the elementary public school level similar to vocational agriculture in high school? What a long-term win for our industry. Hey, even TACC got into the act. Can you believe TACC leadership had the wherewithal to put their foot down, against all odds, & insist that a Joint Co-op Meeting be held just a month ago in the high COVID - rate City of San Antonio, where ultimately nearly 375 people not only attended ---- but it felt like a family reunion!! That took guts & oh it was so special! But it also reiterates the legacy and unexplained imagination of rural leadership.

One of the longest serving state legislators in Texas history, a West Texan, once said on the campaign trail, "Elect me and I will run to not only protect your business & livelihoods, but I will also work to do nothing!" Say what? Yes, do nothing! In his eyes, our people, our families and our businesses are already overregulated & overwhelmed by federal and state agencies that think they can run our lives better that we can ourselves. Someone asked me last week, what has been the highlight of the 2021 state legislative session and my response was, "Heck, it was the non-events that happened: no central filing discussion, no ag lien bill, no grain indemnity talk, no animal welfare fistfights, & no threats on our ag exemptions."

Cutting edge seems to be in fashion today! We are not exempt from it. Just this week, we interviewed a 3.8 GPA kid for our internship program at Texas A&M Kingsville (*our first time ever to that university*) and he is not even a resident of the U.S. One of those diamonds in the rough, bringing different experiences and more maturity & professionalism than most, we were glad to get him placed in a South Texas co-op. We even stepped out on a limb to hold our May 12- 13 board of directors meeting at a recently – opened water park and resort in Round Rock ---- and "hoping" for the best. Turns out, hoping for the best may be the understatement. If it all holds, we are likely to have our largest board meeting in recent times & the facility will be a pleasant surprise for those attending! The guest speaker will be a surprise too. He is the author of the often misunderstood HB 316, which asks for proper meat labelling by those in the plant – based, fake meat business. He's just another example of the John Wayne – type leaders we have in rural America --- willing to do their part to stand their ground for the silent majority.

I know weather – related events are staring us in the face for the umpteenth time in the last decade, but if you talk to old – timers, they take the high road and tell you that comes with the profession --- your forefathers before you have already weathered similar events, so just carry on the tradition, they say. Many would counter, that's easier said than done.

We all like unsung heroes. Agriculture got a good dose of that this past year when many unassuming people who never knew where their milk, eggs, meat & clothing comes from, finally got a wake-up call not only during the great February freeze but also during the pandemic. We don't wish for those ugly events, but there sure were some great takeaways. We saw exceptional traits & an inner strength within our rural leadership that, individually, was what seemed to be a surprise to those experiencing it!



### TACC Returns to Ruidoso in 2021

Now that "normal" is starting to peep its head out again, it's back to our regularly scheduled program --- Ruidoso in July! TACC has two exciting programs coming up: one geared toward general and mid-managers on July 14-16, and another specifically for Board Chairmen on July 28-30. Both meetings will be hosted at the traditional location, Inn of the Mountain Gods Resort in Ruidoso, NM.

Although formal invitations have not yet been sent, TACC is holding a block of rooms at the special rate of \$129, with a cut-off date of June 15th for the Managers Conference. There will also be a \$15 resort fee / night.

The managers conference begins with a lunch at Noon, July 14, followed by an afternoon program and evening reception, a Thursday and Friday morning program --- complete with the traditional golf (\$95) tournament Thursday afternoon. <u>TACC Cooperative New Managers conference for new managers AND new mid – managers hired or promoted within the last two years, will be held the morning of Wednesday, July 14.</u> The registration fee for all attendees will be \$425.

Speakers for the managers meeting include **Joe Outlaw**, a Professor and Extension Economist in the Department of Agricultural Economics at Texas A&M University where he also serves as the Co-Director of the Agricultural and Food Policy Center. **Brian Kuntz**, an area director with the Oliver Group out of Cincinnati, Ohio, will be presenting a new hiring tool that assess the cognitive abilities and personality traits of an applicant called ---- Predictive Indexing. In addition, **Dr. Jennifer Wells**, a Senior Account Manager at Sustainability with Truterra, LLC. out of St. Paul, Minnesota, will be down to explore the possibility of carbon markets. Other speakers / topics are pending!

Lead analysts and senior economist with the CoBank Knowledge Exchange division, **Ken Zuckerberg**, and **Tas Smith**, Vice President of Producers Affairs, from the National Cotton Council will be providing the group with a commodities market update. As is tradition, **Gary McLaren** and **Greg Taylor** will be joining the group to speak on recent and relevant court cases involving or concerning cooperatives, and breaking down Phase II of the Co-op Compensation Study that deals with compensation levels of everyone in the co-op except the CEO.

This will also be the group's chance to meet our 2021 TACC Co-op Summer Interns and help them network with the co-op industry. Be on the lookout for this invitation!



#### **FACEBOOK CONTINUES MAKING AN IMPACT**

Facebook has become one of TACC's main modes of communication with the membership -keeping followers updated on council activities, providing updates on industry, legislative and regulatory changes, and sharing a funny, feel-good story every now and then. (March 18) Ag groups participated in the 8 a.m. House Agriculture & Livestock Committee Hearing at the State Capitol this morning. Two key bills were taken up: 1) one to not allow a city or county to establish an ordinance regarding working animals. Such law is already in state statute, and 2) a bill to crack down on vandalism of and trespassing on animal & crop facilities and property.

#### FACEBOOK CONTINUES MAKING AN IMPACT (CONT.)

(April 8) From the department of "Why Haven't We Done This Before" comes the filing on March 9, 2021 of a one page bill ----HB 3383 --- at the State Capitol by new R) State Representative Glenn Rogers of Graford (75 miles West of Ft. Worth). His bill would require all students graduating from a college or university in Texas to have completed & passed at least one three credit course in agriculture prior to graduation. This bill must pass through the House Higher Education Committee on its way to the Governor's desk. That Committee has as its chair R) State Representative Jim Murphy of Houston, a very strong urban ag vote; R) State Representative John Frullo of Lubbock, another strong urban ag legislator, R) State Representative Phil King of Weatherford, who is avid rural supporter, and R) State Representative John Raney of Bryan, that is a huge supporter of the co-op business model. This sounds like a reasonable expectation for people needing to know where their food comes from, along with minimum requirements for English, math & sciences! Rogers is a practicing veterinarian.

(*April 27*) Increasingly, TACCs position in the area of advocacy on behalf of the ag industry has been, 'We no longer have a choice!' That approach speaks volumes; especially when it comes from an ag student in high school. It seems a Flatonia FFA (*70 miles east of San Antonio on I-10*) student approached & convinced R) State Senator **Lois Kolkhorst** of Brenham to file SB 801. Basically, the bill builds on the already strong FFA programs across the U. S. and asks the Texas Education Agency to implement such a similar ag study program down at the "elementary" levels in public schools across Texas. WOW! The bill passed the Senate on April 30.
