First-ever TACC South Texas Cooperative **Board Chairmen's Conference!**

"Changing the Code, the Culture and the Expectations"

For nearly 20 years, TACC has been hosting a Co-op Board Chairmen's Conference in July/August in Ruidoso, New Mexico, however due to harvest times many of the board chairs in South and Central Texas have been unable to attend. The idea for South Texas was borne recently and it was suggested to be held in conjunction with the South Texas Cooperative Manager / Director Conference. The conference will be a fully-packed agenda for one day on Wednesday, November 2 at the Omni Corpus Christi Hotel (361-887-1600).

The founding focus of the Co-op Board Chairmen's Conference has been the same for nearly 20 years and is still relevant today:

- ♦ To provide the necessary skills to allow a chair to <u>manage the board of director team</u>, rather than traditionally totally relying on the general manager; and
- With the big dollars at stake today and the huge risk associated with running an agricultural or utility business, provide the necessary tools for the board chair to become a better partner with the co-op general manager WITHOUT getting involved in management.

Highlights for the 2016 Board Chairmen's Conference:

- ✓ Two long-time co-op leaders will provide some tools and tips to better working relationships, how they fed off one another, and how they used one another as a "messenger" between management and the remainder of the board,
- Hear of the lessons learned from a co-op board chair and what he would do if he could do it all over again,
- ✓ A recognized, premier co-op manager will give you their view on what they think the model co-op board chair looks like,
- Get down to "nuts and bolts" of the conference by learning how to manage the board and its varied personalities; and
- ✓ A conference would not be complete without focusing on challenging and legal issues occurring within co-op board rooms.

By that afternoon, they were in Friona at **Jason Wright's** family farm. He serves as board chair of Friona Wheat Growers.



Council's **September Board Meeting**

On September 7 – 8, 2016 TACC held its annual Fall board meeting with nearly 60 people in attendance at the Overton Hotel and Conference Center in Lubbock. This was a perfect chance for all board members to come together and brainstorm and give direction for the coming year.

Highlights from the board meeting include:

- ♦ Approved the October 1, 2016 September 30, 2017 budget;
- Received input and initial planning efforts for several upcoming co-op conferences;
- ♦ Added two new board members:
 - Will Coenen, Dairy Farmers of America, Sulphur Springs
 - o Duncan Welch, General Manager, Friona Farmers Co-op Gin, Friona
- Oiscussed the results from the August 2016 TACC strategic plan;
- Reviewed the Council's operations and established the program agenda for the new year;
- ♦ Heard from two 2016 Summer Co-op Interns regarding their experience and set the direction for the 2017 internship program;
- ♦ Guest speakers included U.S. Congressman-Elect **Jodey Arrington** of Lubbock and **Lt. Mark Gumaer** from the Texas Department of Public Safety also from Lubbock;
- Reviewed the Council's financial operations at July 31;
- One of the most moving portions of the board meeting occurred when DPS Lubbock Region Commander **Gary Albus** and several of his key lieutenants joined the group for the Wednesday evening reception in tribute to "Salute the Blue". Albus has long-been an ag-friendly law enforcement supporter for the industry.
- ♦ Heard from numerous industry speakers on a variety of topics; and
- ♦ Selected the D. Williams and Company CPA firm in Lubbock to conduct TACCs FYE September 30, 2016 audit. It will be conducted on November 7 8.



Council Votes to Contribute to Cotton Engineering Scholarship Fund

Long time respected Valley Gin Company General Manager, **Phil Hickman** passed away recently, but his memory lives on. Hickman managed the El Paso Valley Tornillo co-op for years, but also spread his leadership to the cotton industry by serving on the Austin – based Texas Cotton Ginners' Trust (512-615-4800) board of directors for many years. He was also a graduate of the Ag Systems Management program in the Agricultural Engineering Department at Texas A&M University.

A scholarship fund was established in his honor within the department and at the September 2016 TACC Board of Directors meeting, the group voted to contribute \$5,000 to the fund with \$2,500 donated in the 2016 fiscal year and \$2,500 in 2017.

Joining the Rest of the World... TACC Launching an APP!

One of the immediate impacts of the TACC strategic plan in August dealt with technology. As such, TACC will be launching an app beginning in 2017. Research, preparations, and design work is currently taking place for this to happen. "Move Creative", a Lincoln, Nebraska – based company, will be creating the app, with hands-on influence from the Council staff. Move Creative has worked with other agriculture companies designing their apps, including the Florida FFA, Texas 4-H Roundup, and one of our own --- Garden City Co-op in Garden City, Kansas.

This app will have features similar to the current "Guidebook" that TACC uses for meeting schedules, however it appears to be much more detail inclusive. It also offers "push notifications" as opposed to TACC acquiring another service (*texting*). The TACC App will include everything!

TACC is always open to input from anyone who has ideas as to the app content.



Council Takes a Giant Leap to Determine its Long Term Direction _ _ _ _ _

At a special – called meeting, the TACC Executive Committee met over two days in mid-August to attack some lingering challenges of the association and to determine its long term direction. Facilitating the meeting was **Beth Brooks**, the recently – retired CEO of the Texas Society of Association Executives (the coordinating voice for all ag and non-ag trade associations in the state).

The group focused on three major direction-setters: governance, finance and marketing. Some of the resulting outcomes were:

- ♦ to build a 3 5 year financial contingency plan; to include improving non dues revenue.
- establish two task forces to further refine the proper governance structure and second, to properly define membership categories for the association.
- establish a human resource development center; complete with an electronic job posting bulletin board, on-demand how to and training videos, webinars, and other things to assist co-ops in lessening workforce challenges.
- expand communication technologies and frequencies to include an association app, more effective use of Facebook, etc.
- although the Council provides many tools to assist, formalize efforts to further expand marketing assistance to co-op members to help with: better connecting with the emerging leaders within a co-op's trade territory, retention efforts within a membership, effective use of social media, use of grower educational schools, etc.
